### Hillsboro City Council Meeting January 3, 2023

The meeting was called to order at 7:00 pm.

Roll call was taken and those present were Mayor Downs and Commissioners Wright, Butler, Gregory and Ward.

The "Pledge of Allegiance" was recited.

Minutes of the previous meeting were approved.

Commissioners' reports:

Commissioner Butler read his report for public properties and streets and they will be included in the minutes.

Commissioner Gregory read his report for the police department and it will be included in the minutes.

Commissioner Wright read her report and it will be included in the minutes. Wright thanked everyone who has worked on broken water mains this winter.

Commissioner Ward said he has started reviewing all the accounts and rates the City is getting and will be looking to change some accounts if rates are better somewhere else.

Mayor Downs reported 2023 is the bicentennial for the City and thanked the committee working on the celebration. Downs also asked everyone to remember to put their trash cans back after the garbage is picked up and to clean up the dog poop on Main St. and don't leave it there.

Community Planner Sarah McConnell read her report and it will be included in the minutes.

The City Engineer Jeremy Connor reported the 2022 MFT audit will begin soon and work is moving along on the Mechanic St. easements needed for the culvert replacement. Connor said he was working with the Community Planner on some grants and they are working on the environmental assessment for Central Park for the OSLAD grant.

There were no public comments.

**Motion was made by Commissioner Butler** and seconded by Commissioner Wright to approve designing and building a disk golf course in the parks around the Fireman's Clubhouse and the old Girl Scout Camp. David McCormick will design and assist in the

building of the course. The cost will be approximately \$13,000 with design being around \$3,000 of that. Motion carried 5-0.

**Motion was made by Commissioner Butler** and seconded by Commissioner Wright to approve an agreement with Northwater Company for watershed consulting services with will include a watershed plan for the City at a cost of \$126,000. Motion carried 5-0.

**Motion was made by Commissioner Wright** and seconded by Commissioner Ward to approve a partial payment of \$134,032.50 to Korte & Luitjohan for work done on the Huber Dr. water line project. Motion carried 5-0.

Commissioner Butler started discussion on the South Marina and told the Council he was looking at two ways to run the marina. Butler said he got a text from someone that may want to run the marina and he needed to get back with them and talk to them. Butler said at some point a plan needs to be put in place and he wanted the City Clerk to look into getting a liquor license from the state. Butler said he didn't know how long it would take to get the license but he was going to start really looking into the best way to run the marina even if there is no restaurant. Butler said there are a lot of options and wanted to figure it out quickly. Butler said the last lessee is for sure not coming back. Butler said if anyone has suggestions to please let him know.

**Motion to Adjourn was made at 7:59 pm by Commissioner Gregory** and seconded by Commissioner butler. Motion carried 5-0.

Subject: Water and Sewer Report

#### Water:

After the cold spell prior to Xmas, the demand at the water plant increased greatly. Likely due to homes having water run to prevent frozen lines, but also to ones that did freeze and bust. Several homes in the community had leaks. There were also a few large leaks in the resale communities that impacted the amount of water we were pumping. We lost several water meters due to homes not having enough/no heat. We are making a list of these properties and will decide on what happens next. A recommendation to the council will come next month regarding this issue.

The cold water has also impacted the run time on the filters at the water plant. We had to run 24 hours just to produce enough water at the plant to backwash and maintain the water tower level.

The only issue at the water plant due to the extreme cold was a frozen discharge pipe in the Carbon Silo. Once the wind subsided, the heater in the unit was able to maintain and allow staff to resume feeding the chemical.

The actuator was finally programmed to operate as desired and is fully functional.

Over the past weekend, High Service Pump #4 (the large one) suffered some sort of control error. It ramps up and down. We will be looking into the issue, but it's likely an issue with he VFD again.

Sewer:

The cold weather impacted the Locker Plant pump station. Numerous items froze up and shut down the bypass operation. We were able to finally get things thawed out and repaired and all is back going.

The rain overnight caused a significant backup at a commercial property this morning. A large amount of grease was jetted from the sewer along with other items that do not belong in the system. We have confirmed with the property that flow has been restored. We will be looking into our grease trap ordinance due to the issues this became today. Again, a recommendation will be brought back to council on this.

One of the secondary final clarifiers at the WWTP suffered a catastrophic failure last week. The main shaft spinning the collect arms broke, likely due to corrosion below the water line. We are looking at contractors that potentially can make repairs in the tank and will update the council when we have more information.

Again, as a reminder, please to not flush wipes down the toilet or dump cooking oil down the drain. This material is not suitable to enter the sewer mains and causes issues like we had today. The pumps at the lift stations are not designed to handle wipes or wash rags.



The slight reconfiguring of the restroom at the PD is complete and will be used for closet space and computer server room.

The Hillsboro Police Department would like to thank the assisting agencies for assisting with the deceased person located in the creek near Hillsboro High School. Hillsboro Police was dispatched to the area near the Lions Club around 3pm after High School students located the subject. Hillsboro Area Ambulance, Montgomery County Sheriff's Office, IL Conservation Police and Montgomery County Coroner's Office responded. The area was marked off as a potential crime scene and processed by IL State Police Crime Scene Services. Also the police department would like to thank the Hillsboro High School for their assistance in moving student vehicles, cooperating with our investigation by providing video evidence along with the Hillsboro Lions Club for opening their facility to use while the incident was processed. We wish to express our apologies for having to cancel the school functions that were scheduled that evening.

We are still waiting information from the camera company for the LPR's and security cameras quotes. We need to meet with the Public Property Department to gather more information for the Memorial Cameras.

We have requested pricing from Motorola for body cameras.

Hillsboro Police Department received a report on January 1, 2023 just after 7:00am of an unconscious subject in the 700 Block of W. Fairground Ave. Officers arrived and with Hillsboro Area Ambulance and found the male subject to be deceased. Video evidence obtained from the school indicate the male experienced some type of medical issue and collapsed. The Montgomery County Coroner's Office and Hillsboro Police continue to investigate the incident.
