Section 5/11-74.4-4(n) of the Tax Increment Allocation Redevelopment Act (the "TIF Act"), 65 ILCS 5/11-74.4-4(n), states:

If any member of the corporate authority, * * * or an employee or consultant of the municipality involved in the planning and preparation of a redevelopment plan, or project for a redevelopment project or area or proposed redevelopment project area, * * * owns or controls an interest, direct or indirect, in any property included in any redevelopment area, or proposed redevelopment area, he or she shall disclose the same in writing to the clerk of the municipality, and shall also so disclose the dates and terms and conditions of any disposition of any such interest, which disclosures shall be acknowledged by the corporate authorities and entered upon the minute books of the corporate authorities. If an individual holds such an interest then that individual shall refrain from any further official involvement in regard to such redevelopment plan, project or area, from voting on any matter pertaining to such redevelopment plan, project or area, or communicating with other members concerning corporate authorities, commission or employees concerning any matter pertaining to said redevelopment plan, project or area.

As a Commissioner for the City of Hillsboro, I have previously filed with the County Clerk my Statement of Economic Interests, which discloses my interests in Historic Red Rooster, LLC and in Historic Red Rooster Brew Werks & Distilling, LLC. Historic Red Rooster, LLC owns real estate located at 123 E. Seward Street in Hillsboro (P.I.N. 16-02-487-001), which is within a redevelopment area under the TIF Act.

Therefore, I will refrain from any official involvement in the City of Hillsboro's discussions, decision making, and voting on matters related to the redevelopment plan, projects, or area. I will refrain from communicating with other members of the corporate authority and employees concerning any matter pertaining to said redevelopment plan, projects, or area. Further, I will disclose to the City Clerk the dates and the terms and conditions of any disposition of any portion of the property described above during my term as a member of the Hillsboro City Council.

I request that the above disclosure be acknowledged by the City Council and entered into the minutes of the meeting at which this memorandum is submitted.

Section 5/11-74.4-4(n) of the Tax Increment Allocation Redevelopment Act (the "TIF Act"), 65 ILCS 5/11-74.4-4(n), states:

If any member of the corporate authority, * * * or an employee or consultant of the municipality involved in the planning and preparation of a redevelopment plan, or project for a redevelopment project or area or proposed redevelopment project area, * * * owns or controls an interest, direct or indirect, in any property included in any redevelopment area, or proposed redevelopment area, he or she shall disclose the same in writing to the clerk of the municipality, and shall also so disclose the dates and terms and conditions of any disposition of any such interest, which disclosures shall be acknowledged by the corporate authorities and entered upon the minute books of the corporate authorities. If an individual holds such an interest then that individual shall refrain from any further official involvement in regard to such redevelopment plan, project or area, from voting on any matter pertaining to such redevelopment plan, project or area, or communicating with other members concerning corporate authorities, commission or employees concerning any matter pertaining to said redevelopment plan, project or area.

As a candidate for the office of Commissioner for the City of Hillsboro, I previously filed with the County Clerk my Statement of Economic Interests. Thereafter, on April 24, 2023, Articles of Organization were submitted to the Illinois Secretary of State for Hilltop Storage, LLC, in which I have an interest. Hilltop Storage, LLC owns (or soon will own) an interest in real estate located at 1822 Senator Miller Drive in Hillsboro (Suite B), which is within a redevelopment area under the TIF Act.

Therefore, I will refrain from any official involvement in the City of Hillsboro's discussions, decision making, and voting on matters related to the redevelopment plan, projects, or area. I will refrain from communicating with other members of the corporate authority and employees concerning any matter pertaining to said redevelopment plan, projects, or area. Further, I will disclose to the City Clerk the dates and the terms and conditions of any disposition of any portion of the property described above during my term as a member of the Hillsboro City Council.

I request that the above disclosure be acknowledged by the City Council and entered into the minutes of the meeting at which this memorandum is submitted.
