# Glenn Shoals Lake "Total Carpshoot" Bowfishing Tournament

1. All team members must be present at team registration and weigh in.

2. Pre-registered check-in and registration (if spots are still available) will open at 5:00 AM CDT at the Glenn Shoals South Marina parking lot pavilion.

3. The format of the shoot will be **Most Fish**. Each team may submit total number of fish and Big Fish submissions no later than **12:00 PM** (noon) at The Glenn Shoals Lake Marina. Penalty for late arrival at weigh in will be 1 fish per minute. Arriving at the weigh in after 12:30 PM will result in

disqualification. Placement will be determined by the highest total number of fish submitted.

4. There will be an optional Big Fish prize for the biggest fish by weight.

5. Only the following species will be allowed at weigh in: Common Carp (including mirror and leather carp).

6. Fishing is limited to those fish legal to be taken by bow according to the Illinois Department of Natural Resources and the site specific regulations of the waters being fished.

7. The number of people on each boat is limited to the rated maximum occupancy of the boat.

8. Fishable Waters include Glenn Shoals Lake and all creeks accessible from Glenn Shoals Lake.

9. Tie Breaker: In the event there is a tie in total number of fish, the team that has the heaviest single fish wins. Make sure to weigh your heaviest fish.

10. All participants over the age of 16 must have a valid Illinois fishing license.

11. Each boat will be inspected prior to launch and must have the following safety equipment: Proper running lights, fire extinguisher, horn or whistle, life jackets for each individual in the boat, and one being throwable. Prohibited items found during boat inspection must be removed prior to launch.

12. Only single hook gaffs will be allowed in boats during the tournament for landing big fish. Nets, snares or gigs are NOT allowed.

13. Only fish taken during the hours of the tournament will be allowed at weigh in. Any boat possessing fish not shot during those hours will result in immediate disqualification and forfeiture of the entry fee of all team members.

14. All boats must have a lake permit for Hillsboro lakes.

15. All fish must be shot with bow and arrow and show evidence of such.

16. No transferring of fish from one boat or vehicle to another.

17. IDNR requires reporting of fish harvested during the tournament. If your team forfeits and leaves before weigh-in, one member must call or text the tournament organizer and let him know that your team will not be returning for weigh-in. All teams need to be accounted for after the tournament for safety reasons.

18. Any team caught dumping fish on land or returning fish that have been shot to the water will result in immediate disqualification and forfeiture of the entry fee of all team members.

19. Any participant involved in poor sportsmanship, heated arguments or similar behavior will have their team warned or disqualified. Any physical altercations by participants will result in team disqualification, forfeiture of the entry fee of all team members, the participant(s) involved will be banned from any future Glenn Shoals Bowfishing events and will be asked to leave immediately.

20. No alcohol, "non-alcoholic beer" or drugs permitted, before, or during the tournament. Any participant perceived to be under the influence will be disqualified and banned from the tournament site.

21. The City of Hillsboro, Illinois has the right to change and enforce rules as deemed necessary and has the right to deny entry and/or disqualify any team at any time for any reason as they see fit to preserve safety and the integrity of our tournament.

22. Failure to comply with tournament rules will result in disqualification and entry fee will be forfeited.23. The decision of tournament results will be made by staff and/or representatives of the City of Hillsboro, Illinois and will be final.

24. Any accusation of a team cheating must be accompanied by physical evidence of such. The City of Hillsboro, Illinois will have final decision on all protest claims and complaints.
