Business Structure	\$250.00 or .05 cents per square foot (whichever is greater)
Industrial Structure	\$300.00 or .05 cents per square foot (whichever is greater)
Structural Additions	\$50.00 or .10 cents per square foot (whichever is greater)
Accessory Building	\$30.00 Per Building
Mobile Home Unit (Immobilized)	\$30.00 or .05 cents per square foot (whichever is greater)
Sign	\$25.00 or 0.10 cents per square foot (whichever is greater)
Deck / Dock	\$25.00 or .05 cents per square foot (whichever is greater) With a maximum of \$50.00
Driveway	\$25.00 or .05 cents per square foot (whichever is greater) With a maximum of \$50.00
