TRAILER PARKING AGREEMENT – APRIL 1ST THRU MARCH 31ST,_

Agreement between the City of Hillsboro, Hillsboro, Illinois, herein called "COMPANY" and the undersigned boat trailer and/or owner, herein called "OWNER".

- 1. Company shall have a lien against the above described trailer, her appurtenances, for unpaid sums due for use of storage facilities or other services, or for damage caused or contributed to by above described trailer or by Owner to any property of Company or to the person or property of any other person at Glenn Shoals Lake trailer storage facilities.
- 2. This agreement is for the use of trailer storage space at Glenn Shoals Marina only, including the necessary handling of the trailer and placing it in and removing it from storage. The use of such space and related handling of the trailer shall be at the sole risk of the Owner. Company shall not be liable for any loss or damage by theft, or otherwise, to any vessel or property. Owner warrants that Owner's trailer is covered by complete property damage and liability insurance and will remain so covered during the period of storage assigned. Company shall be entitled to assume that such insurance is provided and shall not be required to examine policies to this effect, although such policies shall be provided by Owner for examination upon request. Owner indemnifies and holds Company harmless against any loss, cost, suit or claim arising out of storage space or any handling of the trailer in connection therewith whether or not such loss, cost, suit or claim is based upon negligence of Company.
- 3. This agreement shall be in effect for the period specified unless sooner terminated in accordance with the following conditions, to wit:
 - (a) By destruction of the storage facilities by fire, storm or other calamity.
 - (b) Loss of use of facilities by Company for any reason whatsoever.
 - (c) In the event Owner shall make a bona fide sale of the trailer listed in the agreement.
 - (d) By breach of default as provided in paragraph (4) below.
- 4. Owner agrees to comply with all posted rules and regulations set forth, together with any additional rules and regulations posted from time to time at the storage area, all of which rules and regulations are incorporated herein by reference, and should breach of the agreement or violation of posted rules and regulations occur, this rental agreement shall terminate immediately, and Company may remove the trailer from her storage space at the Owner's risk and expense and retake possession of the storage space.
- 5. Waiver of any conditions by Company shall not be deemed to be continuing waiver.
- 6. Company is authorized to deliver Owner's trailer to any of the persons named above as being authorized to use the trailer, as and when requested, and Company is hereby relieved of any liability as a result of such deliver.
